(1) Type of property

The property must be used solely as a single residential dwelling and be the main residence of the Borrower.

See the prospectus table Indexed Current loan to value Ratios:

The minimum, maximum and weighted average indexed current Loan to Value Ratio as at the Provisional Pool Date of all the Loans (including any capitalised interest, capitalised high LTV fees, insurance fees, valuation fees and booking fees) is 0.3 per cent., 86.4 per cent. and 53.6 per cent., respectively.

All the loans are owner-occupied for main residence and does not include second home loans or buy-to let loans.

On this basis, the loans in the pool meet on average the loan-to-value requirement laid down in point (i) of Article 129(1)(d) of Regulation (EU) No 575/2013, and therefore the requirement (g)(i) is satisfied.
